DESPITE THE DIFFICULTIES PRESENTED BY THE PANDEMIC, GDB STAFF AND ITS COMMUNITY OF PASSIONATE VOLUNTEERS HAVE BEEN ABLE TO PIVOT, EMPLOYING INNOVATIVE WAYS TO MOVE ITS MISSION FORWARD. GDB STAFF HAS CONTINUED TO PROVIDE UNPARALLELED SUPPORT TO ITS CLIENTS EMPLOYING NEW SAFETY PROTOCOLS FOR TRAINING GUIDE DOG TEAMS AND ORIENTATION AND MOBILITY IMMERSION ("OMI") CLIENTS ON BOTH CAMPUSES AND VIA IN-HOME TRAINING.
